The Indian Valley Community Services District (IVCSD) Board of Directors met on June 17, 2026, to conduct regular District business, review operational updates, and consider administrative, infrastructure, and governance matters. Four Board members were present, with one director absent.

Meeting Minutes Approved

The Board approved the minutes from the previous meeting and received public comments. Community members can access meeting recordings and public comments through the District website

Financial and Project Updates

Policy Adoption

The Board adopted a package of consent agenda policies as part of its ongoing effort to modernize and organize District governance documents.

The approved access allows account visibility without transaction authority.

County Coordination and Infrastructure Improvements

The Board approved a letter to Plumas County and authorized replacement of a stem valve on Kinder Avenue to support continued reliability of the District's water infrastructure system.

Administrative Corrections

The Board approved additional clerical corrections to prior banking resolutions to ensure District records accurately reflect approved actions relating to Columbia Bank account administration.

Public Safety Center Coordination

The Board appointed Director Dan Kearns to participate in discussions with Plumas District Hospital and Plumas County regarding continued planning and coordination for the Public Safety Center project.

Park Reservation System Approved

The Board approved a revised Park Reservation Rental Application. The updated document was streamlined to improve usability while continuing to support community use of District park facilities.

Plumas Bank Letter Tabled

The Board discussed a proposed statement to Plumas Bank but voted to postpone action until legal counsel has an opportunity to review the document and provide guidance.

Closed Session

The Board met in closed session to discuss two matters involving potential litigation. No reportable action was taken, and the Board returned to open session before adjournment.
