1. TAYLORSVILLE LIFT STATION IS APPROXIMATELY 95% COMPLETE.
2. SOMMER CUNNINGHAM HAS COMPLETED THE SELF STUDY COURSE FROM SACRAMENTO STATE UNIVERSITY. WE HAVE ENROLLED HER FOR THE CERTIFICATION TEST.
3. REMOVED OLD GENERATOR FROM THE ELEVATED STAND WITH THE HELP OF CODY JOE PEARCE. WAITING ON THE ARRIVAL OF OUR PERMANENT GENERATOR.
4. SECURITY SYSTEM PURCHASE IS IN THE FINAL STAGES.
5. PURCHASED 20 MORE SMART FLOW METERS IN ANTICIPATION OF BEGINNING NORTH MAIN WATER LINE REPLACEMENT PROJECT.
6. PG&E CONTINUES WORKING ON WOLF CREEK ROAD, KINDER, AND PINE STREETS.
7. CAL TRANS ALONG WITH THE LANDSCAPE COMPANY MARINA COMPLETED THEIR PROJECT ON HIGHWAY 89. HOWEVER, THE WATER LINES DID NOT PASS THE PRESSURE TEST. SUSPECT TWO LEAKS UNDER THE HIGHWAY.
8. WE HAD A PRECONSTRUCTION MEETING WITH DIG IT REGARDING THE NORTH MAIN PROJECT. THEY ARE AWAITING THE BRASS PARTS.
9. OUR LEASE FOR OUR OFFICE AND CONNEX BOXES RAN OUT. WE FELT THEIR PRICE TO PURCHASE WAS TOO HIGH. WE MOVED OUR OFFICE TO THE CONCESSION STAND IN THE PARK TO SAVE MONEY. WE ALSO PURCHASED USED CONNEX BOXES AT A SUBSTANTIAL SAVINGS TO THE DISTRICT.
10. RECEIVED A QUOTE ON THE POOL REPAIR. WILL GET A COUPLE OF MORE BIDS.
11. PURCHASED PARTS TO FIX CRESCENT MILLS FIRE HYDRANT.
12. WE MADE APPROXIMATELY \$50,000 ON THE SALE OF POTABLE WATER TO UNDERGROUND UTILITIES AND THE SOIL REMOVAL COMPANY ERRG.
